Many educators across Minneapolis Public School district, neighbors, community members and friends cherish the memory of Bertha Smith. She was a joyful spirit of light for all of us. Bertha helped to develop the paths for countless educators as they



entered the education arena. She retired in 1989, having given 32 years of wonderful service, teaching Special Education through a number of Minneapolis Public Schools programs.

Bertha was the first African American teacher in Minneapolis Public Schools. She knew and believed that it took a village to educate our kids. How astonishing she was, in so many ways! She not only educated students, which she loved with a passion, but she also shared herself by giving, volunteering and helping others.

Bertha was an amazing woman. She did not drive; she walked everywhere she could. Many times she chose to walk rather than take the bus or even accept rides offered to her by others. Bertha was known to share her rich talents through a number of educational outlets, Boards, local and national organizations, volunteering and community service. She also celebrated and supported cultural traditions through financial contributions to help sustain programs in the Arts.

Bertha grew up in the Zion Baptist and the Fellowship Missionary Baptist Churches and throughout her life she continued to be a very active member, especially devoting herself to Missions work and singing in the Choir. She possessed a beautiful soprano voice and she used it well, both locally and internationally.

MRTI Awards Grants to Teachers

Several months ago at an MRTI Board Meeting, a Board member suggested that MRTI should consider giving grants to current Minneapolis teachers. As an organization, we already contribute to several Minneapolis community organizations which directly and indirectly deal with children. We also maintain a scholarship fund for teachers who wish to improve their skills or acquire additional licensure. But we have never offered active teachers funds for use in their classrooms or programs.

After several months of discussion, the Board allocated \$5000 and a committee was formed to create a process for informing teachers of this opportunity, generate the application forms and evaluate the grant requests. When we reached the application deadline, thirty-three teachers had applied and the amount of money requested was more than five times what the Board had allocated!

When the committee finished evaluating all the applications, the results were presented to the Board with the recommendation that "a little more money" be added to the original amount. As a result, we awarded grants to eleven teachers. Grants were awarded to elementary, middle and high school teachers, not only to regular classrooms but to special ed programs and some non-traditional experiences as well. Every teacher who received a grant was absolutely elated and thanked us over and over again.

This was such a rewarding experience that we are discussing the possibility of doing it again this school year. There is a need out there and perhaps we can, in some small way, help fill that need.


