

Committee of 13 - Your Pension Watchdog in St. Paul

The Minnesota Legislature is in session and TRA and other public employee pensions are hot topics. As outlined in Ed Andersen's "Pension Primer" article in the last issue of "After School," the changes proposed by TRA include a reduction in the 2% COLA and an increase in state contribution rates for active teachers.

"The Legislative Commission on Pensions and Retirement (LCPR) chair Rep. Tim O'Driscoll (R-Sartell) asked TRA to address the commission about the TRA sustainability proposal and answer questions about the bill. Laurie Hacking, executive director of TRA, testified about the necessity of passing sustainability measures this session rather than wait a year, as has been suggested. The cost of a one-year delay in passing sustainability legislation would be a loss of \$106.5 million for TRA in foregone revenue from employer contribution increases and foregone savings from COLA changes. Members of several stakeholder groups testified in support of the TRA proposal, including Louise Sundin, Committee of 13 Lobbyist."




